

The Villages of Rancho Del Oro Homeowners Association, Inc.

Pre-Approved Improvements

The following improvements are pre-approved by the Board of Directors of The Villages of Rancho Del Oro Homeowners Association, Inc. These improvements do not require approval by the Architectural Review Committee (ARC) but do require the submission of a Pre-Approved Improvement Application.

Fence Staining

Staining fences using a transparent or semi-transparent stain which does not appreciably change the natural color of the wood.

Vinyl Fences

Front-facing vinyl fence and/or gate sections adjacent to the side of the home are considered a pre-approved improvement only if they are five feet (5') or six feet (6') in height, white in color, and privacy-style. Any proposed variation in location, height, color, or style will require the submission of a Full Application for Architectural Improvement and approval from your respective ARC. Shared backyard fence replacements are a Neighbor-to-Neighbor matter.

House Painting

- Exterior Painting using color(s) identical to the current color(s) of the portion(s) of the house being painted (e.g.: stucco, trim, etc.), OR within one color scheme from the RDO approved color palette (see instructions on pg. 3). Trim colors may be considered for garage doors.

Landscaping

Front Yard: Included: Minor landscape replacements or removals.

Full Application Needed: Major renovations or hardscape installation; tree installation or removal.

Back Yard: Not Included reference CC&R 2.7

Full Application Needed: Installation or change to any water-oriented improvements (e.g., pools, spas, ponds, or fountains), tree removals or installations.

Satellite Dish

Installation of a satellite dish approval is contingent upon it being installed by a professional contractor, with all local and state laws and permits followed. The satellite dish must be placed on the rear of the home, or if on the side of the home, behind the fence line. Any other placement requires approval from the ARC prior to installation.

Solar Panels

Installation of Solar Panels shall be pre-approved, contingent upon the solar panels being installed by a professional contractor meeting the CA Solar Contractor License Qualifications, with all local and state laws and permits followed. Any exposed conduit shall be painted to match the color of the exterior of the home.

Vinyl Windows

Installation of Vinyl Windows shall be pre-approved, contingent upon the windows being installed by a professional contractor, with all local and state laws and permits followed. Pre-Approved exterior frame colors are White, Black, and Tan. Pre-Approved are clear windows only.

EV Charging Stations

In compliance with Civil Code 4745 and all municipal codes, EV Charging Stations are considered a pre-approved architectural improvement so long as it is attached with or on the side walls of the home/garage and installed by a licensed and bonded contractor with drafted installation plans.

Roof Lift and Lay

Removing the current roofing materials and installation of the underlayment of the roof shall be considered a preapproved application so long as no tile replacement is occurring. Must include a neighbor notification form.

Artificial Turf

Artificial turf installation shall be pre-approved, contingent upon the submission of all documentation as specified in Rules and Resolutions #4.8(a).

In accordance with the Supplementary Rules & Regulations, Section 3.19, "All improvements must be completed within one (1) year after the date of approval, unless otherwise specified in writing by the ARC or the Board. If not so completed the Board or the ARC may void the approval and require a new submission for review."

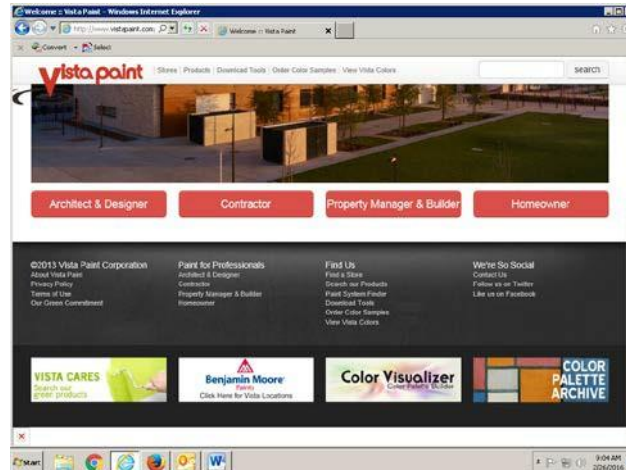
